Not valid with group play, leagues and/or tournaments except as specifically designated by management. Dos Lagos Golf Course is a public facility therefore tee times are subject to availability. Certain time frames, and days may be unavailable to members and guests due to tournaments and/or events.

It is the member's responsibility to show up for and/or cancel tee times that are reserved by you. No show/non-cancelled reservations are subject to a **\$25** fee per person if your group does not show which will be charged the card listed on this membership. Guests of members are not eligible for any discounts. Membership benefits and/or green and cart fees are subject to change without notice. All property including but not limited to cart keys are property of Dos Lagos and members may not keep them at any time.

All members must show membership card(s) and check in everytime they play. Paid cart fees are valid for 18 holes only. Any additional holes played require additional cart fees. Membership card and benefits are not transferable and have no cash value. Members must abide by all golf course policies and rules.

Membership is valid for a 12 month term from the date of purchase. If you elect to cancel your membership for any reason during the 12 month term, you are obligated to pay 50% of the remaining annual term, regardless of payment method. Family membership includes spouse and dependent children 18 years or younger living in the same household. Dos Lagos Golf Course reserves the right to revoke, revise, or modify membership programs at anytime without prior notice. In the event of a revocation of membership, a pro-rata refund of amounts actually paid will be available upon the request of the member. After the initial term, the membership may be available for renewal. There is no guarantee of renewal on the same terms, conditions, or price.

Medical holds will be evaluated by Dos Lagos management and require submittal of proper documentation from your doctor before the hold. The medical hold is for a period of one month minimum/maximum. A "Request for Medical Hold" form must be filled out and submitted, and approved or your membership will not be placed on hold. There is no guarantee of a medical hold. A **\$25** maintenance fee will be charged during the month(s) of the hold. All other holds including but not limited to, travel, personal or any other requested hold are not permitted.
